Students and employees have specific legal rights afforded by the laws of New Jersey. The Board bears no responsibility nor will it be liable for any comments made by members of the public. Members of the public should consider their comment in light of the legal rights of those affected or identified in their comments and be aware that they are legally responsible and liable for their comments.

BE IT FURTHER RESOLVED that the public will be informed regarding the topics discussed in Private as follow:


- a. Upon conclusion of litigation issues
