5. PUBLIC WORK SESSION

- Mr. Yusang Park introduced Jeanne Perantoni of SSP Architectural Group, Inc. She presented and explained the Action Plan Final Report using PowerPoint that identified plans to construct additions to the Middle School and School #2. The Middle School plan will add enough classrooms to house grades 5 and 6, thus giving relief to grades K to 6 schools.
- Mr. Paul Saxton explained that it is a three-year process from referendum until completion of construction. The Board discussed two key issues involving parking and traffic.

Mr. David Sarnoff, offered, seconded by Mrs. Candace Romba, to open the meeting for Public Comments and Questions. On voice vote, motion carried unanimously.

6. QUESTIONS AND COMMENTS FROM THE PUBLIC ON GOAL SETTING FOR 2014-2015

- Various questions, comments and concerns were raised regarding elimination of the artificial turf field at the Middle School, holding baseball games at Constitution Field with no lights and traffic and parking issues. Viability of taking over the Little League field on Board property was also discussed regarding cost of the proposed construction. Jeanne Perantoni said that it is too early to give a precise number.
- Other questions were concerned when the Board would decide what they will bote on and when they will vote.
